In the House of Delegates.

Tuesday, December 3^d 1816.

On this day, the Electors of President and Vice President of the United States, for and on behalf of the State of Virginia, ~~then~~^{having} convened at the Capitol in the City of Richmond; and the General Assembly being informed, by a Communication from the Hon^{ble} Spencer Roane President of the College of Electors, that, the names of the Electors chosen by the people being called over, according to a certified list furnished by the Executive of this State, Mark Alexander of Mecklenburg, Branch T. Archer of Powhatan, George Penner of Patrick, William G. Poindexter of Goochland, Threshley Reynolds of Essex, Braze W. Pryor of Elizabeth City, John Dixon of Jefferson, Archibald Rutherford of Rockingham and John Webster of Harrison failed to attend, at the time and place above mentioned, at three o'clock in the afternoon; the House proceeded, forthwith, by joint ballot with the Senate, to the Election of Electors of a President and Vice President of the United States, to supply the vacancies occasioned by the absence

The Gentlemen above mentioned; whereupon Robert B. Harke of Greenville, William Archer of Powhatan, Benjamin Cook of Franklin, the Honble William Brockenbrough of the City of Richmond, Hay Battaile of Caroline, William Amistead of Elizabeth City, Daniel Morgan of Jefferson, Peachey Harrison of Rockingham, and John Edie of Brooke County, were duly elected to supply the vacancies aforesaid; each person, so chosen, to vote as an Elector of a ~~and to vote as an Elector of a~~ President and Vice President of the United States, in the event of the Elector chosen by the people failing to attend at the Capitol in the City of Richmond, at ten o'clock in the morning of Wednesday the 4th of December 1816.
