We, the undersigned, Electors of President and Vice President of the United States of America duly elected and appointed for, and in behalf of the State of Virginia according to the Constitution and laws of the United States, and the laws of the said State of Virginia do hereby certify that we assembled at the capitol in the city of Richmond, in the State aforesaid, being the place directed for that purpose, by the laws of Virginia, on the first Wednesday, in December, being the fifth day thereof in the year eighteen hundred and sixty, and have voted by ballot for President and Vice President, and have named in our ballots the persons voted for as such in distinct and separate ballots; and in the aforesaid separate and distinct ballots there were fifteen votes given for John Bell, of Tennessee, as President of the United States of America, and none for any other person; and in the like distinct ballots, there were fifteen votes given for Edward Everett, of Massachusetts, as Vice President of the United States, and no vote was given for any other person; and that the foregoing are true and distinct lists of the votes given for the said John Bell as President, and for the said Edward Everett as Vice President

In testimony whereof we have hereto set our hands, on the first Wednesday in December, in the year one thousand, eight hundred, and sixty; and we have also hereto annexed a list of the names of the Electors certified by the Executive authority of this State, under the great seal of the Commonwealth; and, of the names of such Electors as were, according to law, substituted by this Electoral College in place of absent Electors, as shown by a certified extract of the journal of this College, also hereto annexed.
