The undersigned petitioners would most respectfully represent that they are grievously burnd by being requested to pay tolls on the McAdams Road passing through this County of Pulaski and known as the South Western Turnpike Road that there is only one gate erected on said Road within the limits of said County. that a portion of the Citizens of said County are compelled to pass through this Gate when on business requiring them attend once at the Court House or at the Depot of the Va. and Tenn Rail Road in said County that the travel is except that of a local character has almost entirely desisted this Road and lin transferred to the Rail Road the line of which is within a few miles of its entire length that the collection of tolls at the Gate in this County called No 6 while it is burndsome and oppressive to your petitioners is but little or no advantage to the Commonwealth the net revenue if any derived from it being so small that its collection cannot be of the slightest importance to the publick while it is burndsome to your petitioners in going to the Court House to the Depot and to Mill as a large portion of your petitioners is compelled to pass through this gate in going to mill the prayers of your petitioners is that Gate No 6 may be directed to be thrown open and the said Road within the limits of said County declared free to the Citizens of the said County
