of the State of Virginia

The undersigned your petitioners citizens of the  
County of Putnam; would respectfully represent to  
your Hon Body, that on 11 day of March 1860  
Wm. Grap was arrested in this county on a charge  
of Felony, that a trial was had before a Magistrate  
and the said Grap was held to Bail in the  
sum of Three Hundred dollars, and that A. B. Barber  
& A. Marshall <sup>H. W. Bailey</sup> and Mr. Torrey became his  
sureties for his appearance at court; We would  
further represent to your Hon Body that previous  
to the sitting of the court, circumstances compelled  
the said Grap to leave home for a time and  
that the amount of the bond was forfeited and  
was paid by the said sureties; We would further  
represent that the said Wm. Grap returned to this  
county and notified the Attorney for the Common-  
wealth previous to the December court 1860 that  
he had returned and to have the witnesses for  
the Commonwealth summoned to try the case  
that a trial was had and Grap was acquitted  
by the court of the said charge of Felony, We would  
further represent that Grap never was arrested  
after he gave bail but that he voluntarily sur-  
rendered himself to the court.

In view of the above facts we would pray your  
Hon Body to refund to the said sureties the  
amount so paid by them, and thus we will  
ever pray
